<p>Pond dipping</p>	<ul style="list-style-type: none">• Additionally, adults and students provided with anti-bacterial wipes or hand sanitiser to clean their hands, if hand washing is not possible.• Pupils instructed in the correct safe technique for carrying out the dipping and the correct use of equipment.• Pupils given clear boundaries of the working area• Pupils to dip from platforms where they are available (and in good condition)• Adult to ensure good condition of bank from which pupils dip and that there is easy access when platforms are unavailable.• Pupils closely supervised at all times when at the water's edge. Any pupils not at the water's edge will be supervised at a safe location away from the water.• Adults to have appropriate means of rescue to the area being used in case a pupil falls in the water.
